




Fifth Generation of a Family-run Business

Economy in harmony with Ecology


Steel and metal recycling is a form of the market-based principle of dealing efficiently with limited resources. Over and above this, steel and metal recycling is also practical environment protection. Because without recycling, our garbage piles would get bigger and bigger.

Scholz AG contributes to completing and keeping intact the cycle from the secondary raw material right up to the finished product. An initiative that is worth it: by recycling one ton of steel scrap instead of producing it with primary raw materials, about one ton of CO_2 , 0.65 tons of coking coal and 1.5 tons of iron ore are saved. Due to this the CO_2 emissions in the European Union are reduced annually by about 100 million tons, worldwide by more than 500 million tons.

The cycle principle can be seen in nature: Everything is used sensibly; nothing is lost. Similarly, the steel and metal recycling at Scholz does not know any waste. However, recycling is not an end in itself for us, but it must make sense ecologically and economically. Through a continuous focus on quality management, we fulfil this requirement.


